The findings of this review suggest that MT may be beneficial in patients with neck pain in both the short and long term compared to oral pain medications. The authors note that MT had a safer profile and recommend that patients with neck pain be given the option of MT rather than oral pain medications.

# Systemic osteoarthritis: the difficulty of categorically naming a continuous condition


